- (b) (7)(E) conducted firearms quals and less lethal familiarizations
- (b) (7)(E) member arrived in Wisconsin
- A total of (b) (7)(E) personnel are on location
- (b) (7)(E) personnel were on duty
- (b) (7)(E) personnel were staged at the Joint Operations Center to be deployed to support targeted arrests or as a QRF.
- There were no arrests or significant incidents to report.
- (b) (7)(E) has been tasked with providing (b) (7)(E) during the POTUS and AG visit on 9/1/2020
- The downtown area of Kenosha is divided into four quadrants
- (b) (7)(E) to be co-located with local SWAT staged in each quadrant as well as providing a QRF team
- (b) (7)(E) will provide direct support to local SWAT for events unrelated to civil unrest (active shooter, barricades, etc...)
- It is recommended that (b) (7)(E) personnel return multicam uniforms to aide in identification and for tactical considerations

9/01/2020

- A total of (b) (7)(E) personnel are on location
- (b) (7)(E) was tasked with providing (b) (7)(E) during the POTUS and AG visit to Kenosha
- (b) (7)(E) deployed (b) (7)(E), co-located with local SWAT, in forward staging areas
- (b) (7)(E) personnel served as a QRF
- (b) (7)(E) was designated as the lead unit to address tactical operations unrelated to civil unrest
- (b) (7)(E) was supported by FBI Milwaukee and Chicago SWAT and local tactical units
- Several schedule protest received relatively low participation
- The largest crowd size was estimated to be approximately 100
- Crowds dispersed before night fall
- There were no arrests or incidents to report
- IMT began discussing plans for demobilization
