the trigger, he said "no". I then asked, based on his position, does Bowen know if Mensah pulled the trigger, he shook his head no. When asked why Bowen would say that, McKee said, "I guess to make Mensah look like the bad guy". I then asked if Bowen's statement was truthful or a potential lie, McKee said, "Potential lie". I continued reading the following statement, "From my own experience on Saturday night and the statements made in the time since, I have concluded that Mensah's credibility must be questioned. I personally believe he cannot be trusted to tell the truth". I then asked whose statement contained lies; McKee said, "Sounds like him...David". I then asked whose credibility should truly be questioned; McKee said, "Him being a State Representative". I read the conclusion, "In sum, Officer Mensah's actions on Saturday night as well as the elaborate story he's chosen to concoct in the wake of those events highlight one important truth: Joseph Mensah is not fit to represent any community as an officer of the law, and he needs to be removed from that position immediately". I then asked why Mensah has been made out to be the bad person and at which point did Mensah lose the right to defend himself. McKee shook his head up and down. I then challenged him with the statements, 'but this is what the People's Revolution is all about'. McKee stated, "My dad said it the same way you did".

Questionable conduct of Wauwatosa Mayor Dennis McBride

I asked if he would say that the People's Revolution is 'anti-Wauwatosa Police right now'; he said, "at the moment, yes". I then asked, have they ever been 'pro-Wauwatosa Police'; he said, "No". I informed McKee that, during the first protest, Wauwatosa Mayor Dennis McBride was marching right along with them with his fist raised in the air. Additionally, that Mayor Dennis McBride extended a welcome to the People's Revolution to protest anytime. I asked McKee what that made him think; he said, "That he's for us". I then asked what he thought when Mayor Dennis McBride stopped doing exactly what the People's Revolution wanted; he said, "He's against us".

We discussed how Mayor Dennis McBride happily posed in pictures, as archived in photographs taken by Wisconsin State Representative Robin Vining (who was also marching with Dennis McBride and the People's Revolution as a photographer). However, that, after the photo opportunities, Mayor Dennis McBride stopped doing what they wanted, and that the People's Revolution became angry. McKee agreed and said that they (People's Revolution) "had a temper tantrum". McKee agreed that Mayor Dennis McBride acted as if he supported the People's Revolution and that they felt "played" by Mayor Dennis McBride.

I pointed out that the People's Revolution demanded that there be a civilian oversight committee in charge of the police department, McKee was aware of this. I pointed out that the Mayor Dennis McBride created this committee, in accordance with their request, and put two members of the People's Revolution in charge of it (Chair and Vice-Chair), McKee was aware this. I then asked if there are people that hate you, should they be in charge of you; McKee shook his head no. I, again, pointed out that Mayor Dennis McBride still completed this act. I then asked McKee if he thought it was appropriate for an elected official to change rules and appoint non-residents to a Police oversight committee, when those people hate the police, McKee shook his head no.

Revisit of Incident: Pepper spray

I circled back to the incident at Mensah's house; specifically after the shot went off. McKee said that Bell threw it (shotgun) back in "Will's truck". I asked again if Bell threw it back in the truck or gave it to McKee, he said, "he throws it in the back of the truck". McKee also said that the group pulled off and that he went back to "Lizzie's car". McKee then offered that there was "mace" sprayed by "Mensah or his wife" but admitted that he did not see them spray. I then asked why he said that Mensah or his wife sprayed it; McKee said, "I just figured, that's what they told me, his wife sprayed it". I referenced the video that had already been circulating and told him that the person that claims to have mace in their eye was in the street and offered that one of their own security members was responsible for the spray.

Shotgun and riding on Lofton's vehicle

I then came back to the shotgun. I asked if McKee was sure that he left in Lizzie's car. McKee said that the people in Lofton's vehicle were Lofton, Bell and "Mary". I then asked who was on top of Lofton's car, McKee said, "a couple people". I then pointed out that, at the moment the group left, there was only one person on top of the truck. McKee asked, "Who was the one", I told him to tell me; he responded, "I did climb up there to see the crowd" but contended that Lofton was not moving at that time. I asked if he was still on top of the vehicle when Bell got into it, McKee said, "yes". I asked how long he rode on the top until Lofton stopped and allowed him to get down and get into Lizzie's car; he said "a couple miles" and then said, "Not a couple miles, a couple
